Ron May/ Community Crossing Matching Grant

Ron May announced that the City of Greensburg was awarded Project #1 and #3 in the amount of \$701,715.29 with the Community Crossing Matching Grant.

Kathy Reynolds/ Animal Control Ordinance

Kathy brought to the Council Animal Control Ordinance Amendment 2017-21. Motion for approval was made by Jamie Cain, seconded by Vietta McKenzie; voice vote recorded 2 ayes and 2 nays; motion did not pass. motion passed.




