Pledge of Allegiance was recited.

Brendan Bridges/Ordinance

Chief Bridges introduced the 1st reading of Ordinance 2017-4 for the K-9 Fund and Ordinance 2017-5 for the Bike Patrol Fund. Chief Bridges requested approval of both Ordinances. Motion for approval was made by Jamie Cain, seconded by Darren Covington; voice vote recorded all ayes no nays; motion passed.

Steve Garrett/ Ordinance

Chief Garrett introduced the 1st reading of Ordinance 2017-6 Fire Safety Fund. Motion for approval with an amendment adding Firefighter Training/Fire Prevention was made by Darren Covington, seconded by Vietta McKenzie; voice vote recorded all ayes no nays; motion passed.

Ashlee Green/Ordinance

Ashlee Green introduced the 1st reading of Ordinance 2017-7 Cash Change Funds. Ashlee explained that any department with cash on hand to give change should have a Cash Change Fund Ordinance. Motion for approval was made by Darrell Poling, seconded by Kevin Fleetwood; voice vote recorded all ayes no nays; motion passed.

Mayor Manus gave an update on the Stellar Community Program and advised Council that finalists will be selected on May 24th, 2017.


Mayor Manus advised Council that one of the trash trucks had broken down. Mark Klosterkemper advised Council that to get the 2004 International fixed would cost thousands of dollars. Mark also explained that the trash truck that is needed with high compaction would take approximately 2-3 months to receive. The Council advised buying the trash truck that would meet the city's needs for approximately \$160,000.00, which would be paid from trash tipping fees, and leasing/renting one until the new trash truck arrives. Motion for approval was made by Jamie Cain, seconded by Vietta McKenzie; voice vote recorded all ayes no nays; motion passed.

Mayor Manus also requested support to hire a Building Commissioner to help enforce Ordinances. The Building Commissioner would be paid from EDIT for this first year. Motion for support of this decision was made by Darrell Poling, seconded by Darren Covington; voice vote recorded all ayes no nays; motion passed.


Darrell Poling gave the BOW report.

Meeting adjourned at 8:02 P.M.






